

# Chief Health Officer

## THE ORGANIZATION

The Flathead City-County Health Department is a public health agency providing statutorily mandated services and other contracted services to people who reside in or visit Flathead County. The divisions of the Health Department offering primary prevention services include: Environmental Health Services, Community Health Services, Health Promotion, and the Flathead County Animal Shelter. The Health Department offers primary health care services through the Flathead Community Health Center, Flathead Family Planning and Flathead County Home Health.



## **THE POSITION**

The Chief Health Officer is the primary administrator for the Health Department and is responsible for the planning and execution of the Board's mission, programs, and strategic plan. While the Chief Health Officer reports directly to the Board of Health, they should also cultivate positive relationships with the Board of County Commissioners and the governing bodies of the local cities and towns.

In this role, you will:

- Orient the Board of Health with respect to trends, issues, concerns, regulatory changes, technology, and other relevant factors to facilitate the Board's decision-making processes
- Provide the Board with reports of Flathead City-County Health Department's operations and activities, providing information, analysis, and recommendations as appropriate
- Work closely with federal, state, and local officials, agencies, community health providers, and the public to ensure program efficiency and compliance with applicable laws, rules and regulations
- Assess community public health needs, develop and implement supportive health services and programs to fit
  those needs
- Communicate Health Department issues to the Board of Health in an appropriate manner; communicate personnel issues to Personnel Committee of Health Board
- Perform all other duties that must be performed by a Health Officer as delegated, ordered, or assigned by the Board of Health or in accordance with MCA 50-2-118
- Manage 50+ employees in seven different divisions and administer a budget totaling \$14.5 million.

The Flathead City-County Board of Health seeks a seasoned public health professional to become its next Chief Health Officer. The ideal candidate will be **knowledgeable in both community and environmental health programs**, preferably with increasing responsibility in at least one of those fields.

This experience will be complemented with demonstrable **management skills** in communication, motivation, mentoring, and general administration of a public agency. The successful candidate will



be confident, **be collaborative, and will inspire trust** with staff, the board, and the public. This person must have previous experience working directly for a board of directors in a mutually supportive environment.

Lastly, the ideal candidate will appreciate and desire to embrace the distinctive northwest Montana lifestyle: **scenery so delicious, you could almost eat it**; a cordial, family-friendly, and independent community; and all-season outdoor recreation.

## **EDUCATION AND EXPERIENCE**

Competitive applicants must possess a degree that qualifies them as a physician (such as a Medical Doctor/M.D.), a Master's degree in Public Health from an accredited college or university, or equivalent education and experience as determined by the Department.. Significant and increasingly responsible management experience in a community, environmental, or clinical health setting is preferred.

## COMPENSATION AND BENEFITS

Negotiable between **\$90,000 - \$110,000**.

The Health Department offers a generous benefits package, including:

- Medical, Dental, and Vision
  (traditional or HDHP + HSA)
- 7.9% required pre-tax contribution of gross wages towards a defined benefit or defined contribution plan in the Montana Public Employee Retirement Systems (8.77% match from the County/State)



- 15 vacation days per year (previous Montana government employees eligible for higher accruals)
- 12 sick days per year
- 10 holidays per year + 1 day for State General Elections
- Compensatory time off: exempt employees receive compensatory time off for hours worked in excess of 40 hours/week at a 1:1 ratio subject to certain conditions
- County vehicle and phone
- Relocation may be negotiable
