THE POSITION

The City of Tampa is seeking a highly motivated leader with demonstrated skills in the municipal development and construction arena to become its next Construction Services Manager and Chief Building Official (Construction Services Manager). This person will lead a critical operation during a time of explosive growth and progressive change and will help to establish, execute, and maintain existing and new initiatives that support the Mayor's vision for Tampa's future. In overseeing both strategy and day-to-day operations, this role will work across internal and external stakeholders to deliver top-quality services in a transparent and highly accountable manner, while ensuring that the department enforces compliance and development standards.

This high-level role will lead and direct the City's permitting, inspection, and building construction oversight functions in a dynamic and fast-paced environment. The Construction Services Manager has three direct reports and oversees a diverse team of 89 full time employees which reflects the wider Tampa community. The division is engaged in all aspects of the development and neighborhood community.

IDEAL CANDIDATE

The selected candidate will be a seasoned professional in commercial building construction, construction management, or engineering. Because the City of Tampa is undergoing major growth in virtually all construction sectors, the ideal candidate will bring a full suite of experience from multi-phased, large scale, or high-rise developments to smaller residential projects. Additionally, knowledge of environmental procedures as well as seaport and airport developments is preferable.

The Construction Services Manager leads the division as an expert in reading and interpreting building materials, construction standards, plans, blueprints, and specifications. This requires tact when interacting with the public to enforce code requirements with firmness and impartiality, but also skill to find innovative solutions to facilitate projects whenever possible. As an excellent communicator, the Construction Services Manager can routinely engage with a variety of stakeholders, including other city staff, attorneys, architects, engineers, developers, and most importantly the general public.

Finally, the selected candidate will be an experienced manager with a focus on providing excellent customer service. Given that much of the work in this division is completed by autonomous staff, the Construction Services Manager will possess skills to review performance, motivate employees, and revise workflows to achieve optimum customer service. This won't be a back-room position the next Construction Services Manager will be expected to lead from the front, build consensus, and embrace the team's innovative ideas. This person will embrace diversity by hiring, mentoring, and retaining a workforce that reflects Tampa's diverse population.

This is a key position for the City at this time. The City is growing at an unprecedented pace, and the Construction Services Managerwill play an integral role in the City by making innovative and bold decisions as a change agent to facilitate an easier development process.

EDUCATION AND EXPERIENCE

Graduation from an accredited college or university with a degree in civil, structural or construction engineering, architecture or related field and five (5) years of experience in duties related to commercial building construction, inspection and/or design, or in administration of regulatory controls relative to building construction including three (3) years of administrative and supervisory experience; or an equivalent combination of training and experience.

Possession of Building Plans Examiner and Building Inspector licenses; a valid Florida driver's license. Must apply for a Provisional Building Code Administrator Certificate immediately upon hiring and obtain a State of Florida certification as a Standard Building Code Administrator within 12 months of the issuance of the Provisional Building Code Administrator Certificate.

Ideally, candidates will possess both construction management skills as well as a building code administrator license. However, candidates without an existing license could be considered if they possess the right mixture of subject matter expertise, management experience, and vision to match the City's needs.

COMPENSATION

Compensation and benefit package will be competitive and negotiable depending on the experience and qualifications of the chosen candidate. The salary range is \$84,094 - \$131,788. A standard <u>City of Tampa benefits package</u> is included.
