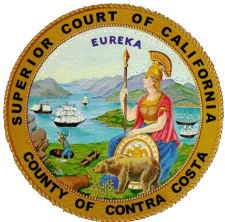

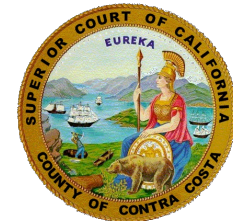

To be a California certified and/or a registered court interpreter, a person must:

- Be at least 18 years old
- Possess applicable language skills
- Pass the oral, written and BIE (Bilingual Interpreting exam) exams.

An applicant must be able to facilitate communication to flow between the court and court customers in a court setting. This includes the ability to interpret with high accuracy and the ability to accurately translate content from one language to another in a judicial setting.

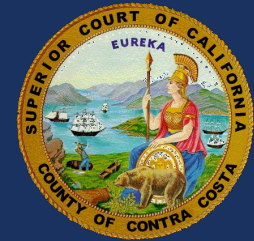
